Use only non-sparking tools. Vacuum clean-up is preferred. If sweeping is required use a dust suppressant. Use water to suppress dust. Contact competent authorities after a spill.

### SECTION 7: HANDLING AND STORAGE

#### 7.1. Precautions for Safe Handling
